VENDOR CATEGORIES DEFINED	
Artisan	Vendors creating non-edible items that are of a practical or ornamental nature. Examples include: ceramic ware, clothing and textiles, wood products, etc.
Food Producer	Vendors producing prepared food items such as baked goods, preserves, food court items such as: soup & sandwiches, waffles, sausages, etc.
Farmer/Grower	Vendors who are bona fide farmers raising livestock or growing produce. Growers of food. (fruits & vegetables, herbs, eggs, dairy products, meat, etc.)

VENDOR SUMMARY & CHECK LIST

- Read the Rules, Regulations and Policies of the Cape Breton Farmers' Market Co-Operative Limited to ensure you are in agreement and able to meet all requirements
- Complete the Application Form. If you are an Artisan, include photos representative of the products intended for sale. If you are a food vendor, make sure you have read the guidelines and have the required permits.
- Mail or give your application to the Market Manager using the addresses, etc. shown on the application or drop it off at the Market on a Saturday from 8:30am to 1:00pm.
- Please note that applications will be reviewed for approval and selection in the order received.
- If requested, make arrangements for the Vendor Committee to view your products or place of production.
